III – General rules of the Tournament

The competitions are organised according to **EFC Rules for EG 2015 Qualifying tournament**.

Entry fee: 100 EURO/fencer

IV – Confirmation of presence

Final confirmation of participation at competitions must be done not later than 2 hours prior to start of concerned competition.

V – Competitions

All information related to the Tournament will be published on the venue at "Gerevich Aladár Sportcsarnok".

Only FIE current ranking list will be considered.

All inscriptions are to be done by national fencing federations through EFC web site.

The Tournament will run on 4 pistes equipped by video refereeing system Atlas (ESP).

Draw of fencers into pools will be done according the formula prescribed by the FIE.

Following to EFC Rules for that event the competitions will stop at the moment when the quota of qualified fencers is reached, i.e. after quarterfinals in all weapons!

VI - Venue

Only concerned fencers, referees and piste personnel are entitled to enter inside of barriers.

Fencers have to keep their bags closed at indicated place indicated during their fights of matches.

Fencers and referees are entitled to enter inside of barriers to indicated pistes 10 minutes before the start of fights

VII – Information points

The information and results will be available on the venue.

VIII – Results confirmation

- 1) Responsibility lies with the fencers at verifying results of pools and bout sheets of direct elimination in order to control correct registration of results.
- 2) In order to avoid some mistakes DT will publish results of pools and list of qualified and eliminated fencers after pools. Any complaint should be brought to DT within a deadline of **5 minutes after published results**.
- 3) **No calls by microphone will be used.**

IX - Organisation of direct elimination table

In a view of very low number of participant fencers no call room will be used. However, the fencers should follow published information in order to be present on the pistes at indicated time.
